

**OFFICE OF THE DISTRICT AND SESSIONS JUDGE, FARIDABAD**

**ORDER:-**

In view of the guidelines issued by the Hon'ble High Court in letter No.31522/Gaz.II(10) dated 19.09.1995, regarding making of arrangement for entertaining urgent matters such as bail application/injunction/stay matters during a holiday spell of 4 or more holidays including Saturday and Sunday both in the Sessions Courts as well as in the Lower Courts, it is ordered that the following Superior Judicial Officers shall perform duty during the holiday spell i.e from 31.10.2024 to 03.11.2024:-

Sr.No.	Date	Name of the Judicial Officers who shall perform duty during holiday spell
1.	31.10.2024 & 01.11.2024	Sh.Amrit Singh, Addl.District and Sessions Judge, Faridabad
2.	02.11.2024	Sh.Purushottam Kumar, Addl.District and Sessions Judge, Faridabad
3.	03.11.2024	Sh.Sanjay Kumar Sharma, Addl.District and Sessions Judge, Faridabad

The timing for filing of urgent fresh cases/bail applications etc. during the holiday spell would be between 11:00 a.m. to 12:00 p.m. The Superior Judicial Officers shall hold the Court from 11:00 a.m. onwards. (ADD)

The urgent civil and criminal matters (including bail applications) which shall be instituted on 03.11.2024 (except decided bail applications) shall be put up before the undersigned/senior most Superior Judicial Officer on duty on 04.11.2024, for proper assignment.

Similarly, urgent civil matters pertaining to the courts of Civil Judges (Sr./Jr.Divn.), Faridabad, which shall be instituted during the aforesaid holiday spell shall be entertained by the Duty Magistrate of the particular day(s). However, the same shall be put up before the Civil Judge (Sr.Divn.), Faridabad on 04.11.2024, for proper assignment.

All concerned be informed accordingly.
