## NOTE:-

- 1. In case, any Judicial Magistrate on duty, proceeds on leave during the duty period, he/she shall make an alternative arrangement for duty work in his/her absence and shall obtain the consent of the Officer in writing, under intimation to this office as well as to the Addl.Chief Judicial Magistrate, Faridabad.
- 2. The Judicial Officers performing duty during the winter spell shall be allowed to avail special casual leave upto June, 2025, as per the instructions of the Hon'ble High Court issued on the subject.
- 3. All types of civil cases to be presented on 01.01.2025 shall be entertained by Judicial Officer who shall be Duty Magistrate on that day, as per duty roaster of the month of January, 2025. However, the same shall be put up before Sh.Sandeep Yadav, Civil Judge (Sr.Divn.), Faridabad on 02.01.2025, for proper assignment.
- 4. In case of heavy institution of fresh civil cases during the period from 25.12.2024 to 31.12.2024, Sh.Sandeep Yadav, Civil Judge (Sr.Divn), Faridabad may assign civil cases to the next senior Judicial Officer on duty during that period.
- 5. The protocol duty if any, shall be performed by the Senior Magistrate on duty.
