<b>STEP I</b>	Open Web-browser of your mobile phone (google chrome, or safari or opera.etc.) and Open the website of this Sessions Division i.e. <a href="http://districts.ecourts.gov.in/faridabad">http://districts.ecourts.gov.in/faridabad</a> and then Click on the tab “Video Conferencing Link” under “Magistrate > Duty Magistrate” tab Or “Quick link” tab.
<b>STEP II</b>	Click on the link of the Concerned Court as per list of links shown below,
<b>STEP III</b>	After Clicking on the Court Link you have Joined in Video Conferencing of Concerned Court.
