

- 2 The names of candidates mentioned in List No.1 of Adhoc Peons are higher in merit than candidates mentioned in List No.2 of Contractual Peons. So, the candidates of General Category, PWD and DSC Category mentioned in the List No.1 of Adhoc Peons shall be given an option to choose whether they intend to opt for the post of Contractual Peons meant for Fast Track Special Courts, Faridabad, before any appointment letter issued to them. The exercising of this option is mandatory. Furthermore, in case any of the candidates of the aforesaid categories in List No.1 chooses to opt for contractual post of Peons, then the contractual Peons mentioned in the List No.2 in order of their merit, shall be given an option to opt for post of Adhoc Peon or to continue on post of contractual Peon. In case, the higher rank candidates from the List No.2, does not opt to join as an Adhoc Peon, then in such a situation, the last candidate of that category shall take place in Adhoc List No.1
