Under notification dated: 248/2022 dated: 13/06/2022 applications were called for from the eligible candidates to fill 3 posts of Typist Copyist, two from the Local Cadre (KKR) and one from Non Local Cadre (RPC). In the Local Cadre one post was reserved for GM (R) and another one from IIIA (O). In the Non Local Cadre the post was reserved for IIB (O).

To fill up the said posts skill test was conducted on 22/09/2023 and 23/09/2023. After evaluation of the answer sheet the undermentioned candidates have secured top 5 highest marks in respective category
