The District Legal Services Authority Ballari invites applications from eligible advocates for empanelment as Panel Advocates to provide legal services to eligible persons under the Legal Services Authorities Act, 1987.

1. Eligibility Criteria:

Applicants must fulfill the following criteria:

- Must be an Advocate enrolled with the State Bar Council.
- Must have a minimum of 3 years of experience in practicing law.
- Must possess a valid Certificate of Practice.
- Must not have any pending disciplinary proceedings or criminal cases.
- reference may be given to advocates having experience in Criminal Law, Civil Law, Family Law, Labour Law, Matters related to marginalized sections of society (SC/ST, Women, Children, etc.) and Legal Aid cases
- Knowledge of local language(s) is desirable.

- *Must be willing to provide legal services as per the norms and guidelines of the DLSA.*

2. Scope of Work:

Panel Advocates will be required to provide the following legal services:

- *Legal advice and assistance.*
- *Drafting of legal documents.*
- *Representation in courts and tribunals.*
- *Conducting legal awareness programs.*
- *Mediation and conciliation.*
- *Any other legal work assigned by the DLSA.*

3. Application Procedure:

- *Interested advocates may obtain the application form from the office of the DLSA Ballari.*
- *The application form can also be downloaded from the official website.*
- *The duly filled application form, along with self-attested copies of the following documents, must be submitted to the office of the DLSA, Ballari on or before 03.05.2025.*
- *3 Passport size photographs.*
- *Enrollment Certificate.*
- *Certificate of Practice.*
- *Certificate of Experience*
- *Aadhar Card.*
- *Any other relevant documents.*
- *Applications received after the last date will not be considered.*

4. Selection Process:

- *The selection of Panel Advocates will be based on the eligibility criteria, experience, and performance in an interview/interaction conducted by the Selection Committee constituted by the DLSA.*
- *The decision of the Selection Committee shall be final and binding.*

5. Terms and Conditions:

- *The empanelment shall be for a period of 3 years.*
- *The remuneration/honorarium shall be paid as per the norms and guidelines of the Karnataka State Legal Services Authority Bengaluru.*

- Panel advocates are expected to maintain professional standards and confidentiality.
- The DLSA reserves the right to terminate the empanelment at any time without assigning any reason.


