- [3] All the Execution Petitions and Miscellaneous Application filed under the Motor Vehicles Act, be placed before the Tribunal on whose file the particular Motor Accident Claim Petition, is pending OR be placed before the Tribunal, who has decided the particular Motor Accident Claim Petition.
- [4] At the time of institution of Miscellaneous Application filed in Motor Accident Claim Petitions for disbursement of awarded amount, the order regarding "Nazir to verify and Report" be passed and be placed before the Tribunal who has passed order/ decree.
- [5] Bail application under the POCSO Act , the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act 1989, the Prevention of Corruption Act 1988, the N.D.P.S. Act and under any Special Acts should be placed before the Special Court for necessary Order.
