Procedure to lodge/file an Online Complaint:

Women Employees of District Court Amreli Complaints regarding Sexual Harassment against her can be made either in paper form or by sending email to iccdcourtamr@gmai.com.

The Act stipulates that aggrieved woman can make written complaint of sexual harassment at workplace to the Internal Complaint Committee, within a period of three months from the date of the incident and in case of a series of incidents, within a period of three months from the date of last incident.

As per the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Rules, 2013, in case the aggrieved woman is unable to make a complaint on account of her physical incapacity, a complaint may be filed inter alia by her relative or friend or her co-worker or an officer of the National Commission for Woman or State Women's Commission or any person who has knowledge of the incident, with the written consent of the aggrieved woman.
