- (1) All the bail Applications including successive bail application filed under the same CR. Number and by same accused or co-accused be placed before the same Judge who had decided the previous bail application.
- (2) All the Bail Applications filed after the charge-sheet is filed be placed before the judge on whose file the perticulars Sessions Case is pending and if the particular Sessions Case is not allotted, than as per Note-1.
- (3) All the Execution Petitions and Miscellaneous Applications filed under the Motor Vehicles Act, be placed before the Tribunal on whose file the

particular Motor Accident Claim Petition, is pending OR be placed before the Tribunal, who has decided the particular Motor Accident Claim Petition.

- (4) At the time of institution of Miscellaneous Application filed in Motor Accident Claim Petitions for Disbursement of awarded amount, the order regarding "Nazir to verify and Report" be passed and be placed before the Tribunal who has passed order/decreed.
- (5) Bail application under POCSO Special Act and the Scheduled Castes and Schedule Tribes (Prevention of Atrocities ) Act.1989 and N.D.P.S. Special Act, and under any special Act should be put before the Special Court for necessary order.
