In Pursuance of the direction contained in the letter of Honourable Gujarat State Legal Services Authority, Ahmedabad read above, the undersigned is pleased to constitute a bench for settlement of the Matrimonial disputes in Permanent Pre-litigation Lok Adalat comprising of following members with immediate effect, as per the direction contained at Para (4) of Standard Operating Procedure (SOP) for settlement of Pre-litigation matrimonial and martial disputes/cases as under:

1.	Principal Senior Civil Judge, Nadiad	CHAIRPERSON
2.	Mr. Umesh A. Dhagat, Mediator	MEMBER

Moreover there is only one Family Judge in Kheda District and when additional family Judge is appointed in district, Principal Senior Civil Judge shall be replaced by him or her, from the said Committee.


The aim of the bench is to effective implementation of provisions of the Standard Operating Procedure (SOP) for settlement of Pre-litigation matrimonial and martial disputes/cases. The Committee shall evaluate all applications presented before the Bench and identify the disputes into matrimonial matters and resolve them at earliest stage and also efforts will be made by the committee of two members to settle the matrimonial disputes on the basis of settlement through pre-sittings.

The bench will operate in accordance with the standard operating procedure prescribed for this purpose. The bench will convene weekly, specifically on each working Saturday before or after office hours and not at all during court hours. The Committee shall endeavor to resolve matrimonial disputes on the basis of settlement through Pre-Sittings.

Any administrative expenditure that may be required to incurred out of the Cost Fund available with the DLSA.

Any other expenditure that may be required to incur shall be arranged from the State Fund or Fund available with GSLSA.

The notification shall become effective upon the commencement of the scheme by the esteemed and auspicious hands of the Hon'ble Chief Justice of the Gujarat High Court.
