

Therefore, in addition to the instructions contained in the Circulars cited at Serial No. 1 & 2 as above , I am directed by the Hon'ble the Chief Justice to inform all the Judicial Officers of the District Judiciary that, they will attend the Administrative work, dictation of Judicial Orders/Judgments and other Miscellaneous work during the periods from **10:30 a.m. to 10:45 a.m.** and **5:00 p.m. to 6:10 p.m.** on Court working days. It came to the knowledge of the Hon'ble the Chief Justice that large number of judgments and orders are pending for pronouncement, therefore all the Judicial Officers of the District Judiciary are directed to pronounce the judgment/order in all pending matters which are kept for pronouncement of judgment/order on or before 15<sup>th</sup> May 2024, without fail.

All the Judicial Officers in the State are directed to follow the aforesaid directions scrupulously, failing which, serious view will be taken by the High Court and action will be taken on administrative side for dereliction of duty.
