The Office will not take any responsibility for delay, loss or non-receipt of quotations sent by post. The sealed tender will be opened on 03.04.2025 at 4:45 p.m. in conference room at ADR centre, District Judges' Court Complex, Dakshin Dinajpur at Balurghat, in presence of Ld. Chairman and Secretary, D.L.S.A., Dakshin Dinajpur at Balurghat.
- Rates should be quoted taking into account the description, make, type, specification and quantity of the article for which quotations have been invited.
- Rates quoted should be inclusive of all applicable charges, taxes, duties and levies.
- At the time of payment, this office must be **deducted 1% TDS** on quoted/total amount as per taxation rules/Act.
