- 2. The furniture shall be in accordance with the specifications made in the tender Notification, otherwise the same will be rejected summarily.
- 3. The Tender Notification will be displayed in the Prl. District & Sessions Court, Mysuru, Notice Board.
- 4. The tender notification may also be obtained in website : https://districts.ecourts.gov.in/mysuru.
- 5. Last date for receipt of tender is before 4 PM on 09-02-2024.
- 6. The tender will be opened at **6.00 P.M on 12-02-2024** in the presence of tenderer or their agents, if any.
- 7. The tenderer shall quote the rate for each article inclusive of all taxes, levies, freight, other expenses, GST as applicable and transportation charges etc., shall be considered to determine the lowest rates.
- 8. This office will get the furniture inspected by the Department of Industries and Commerce for Steel furniture after supply to this office. The office will make payment only after the acceptance and inspection of the furniture.
- 9. The Supplier should deliver the furniture at his own cost to the destination as directed by the Prl. District & Sessions Judge, Mysuru.
- 10. The rates quoted for any reasons or under any circumstances will not be changed.
- 11. The tenderer shall deposit EMD amount of **Rs. 4,500/-** through DD drawn in f/o Prl. District & Sessions Judge, Mysuru. On any Nationalized Bank,

- towards supply of Steel furniture which is refundable to the unsuccessful tenderer as early as possible and will be handed over to successful bidder only after supply of furniture.
- 12. Cost of preparation of offers, attending the quotation opening and appearing before the Committee for negotiation/clarification shall be borne by the vendor.
- 13. The right of accepting or rejecting the tender is reserved by the undersigned. The undersigned may reject the tender without assigning any reasons.
- 14. The Tenderer shall furnish an unconditional warranty for a period of 2 years.
- 15. The damaged articles if any at the time of delivering the furniture shall be replaced within 15 days from the date of return.
- 16.The E.M.D amount of the successful tenderer will be forfeited to Government, in case of violation of the terms and conditions.
- 17.As the payment will be made by preparing bills in Khajane-II within this financial year, successful bidder have to submit bills in duplicate along with copy of Bank Passbook, PAN, Recipient ID if available. The furniture shall be supplied within **10 days** from the date of issue of work order, otherwise the allotment will be lapsed to Govt.
- 18. Copy of the Registration Certificate issued by the Government/competent authority regarding validity date for supply of furniture should be furnished along with quotation.
- 19. The authorized vendor shall furnish upto date GST Registration Certificate a well as GST Clearance certificate.
