ORDER P.R.NO.171-A/2023

In pursuance of the Hon'ble High Court's Letter ROC 4th cited above, the candidates who were provisionally selected in the Second List as per reference 3rd cited, for the posts of **FIELD ASSISTANTS**(Cat.10 of A.P. Judicial Ministerial and Subordinate Service Rules) as notified in the Notification 1st cited, in the Unit of District Judge, Visakhapatnam, in the time scale of **Rs.25220-80910**, the undersigned is pleased to pass the following temporary appointments and postings orders:

1. **SRI REDDI SAILAJA (BC-D)**, D/o.Reddi Srinivasa Rao, R/at D.No.28-66-2, Vadlapudi, Visakhapatnam-530046, who is provisionally selected to the post of Field Assistant against **R.P.No.30(OC-W) in II Cycle** in A.P. Judicial Ministerial and Subordinate Service in the Unit of District Judge, Visakhapatnam, is temporarily appointed as **Field Assistant** and posted to act as Field Assistant, Principal Junior Civil Judge's Court, Bheemunipatnam, in the existing vacancy.
2. **SRI DODDI SANDEEP(BC-A)**, S/o.Doddi Venkateswara Rao, R/at H.No.19-205-1, Kothapeta, Yelamanchili Mandal, Visakhapatnam District-531055 who is provisionally selected to the post of Field Assistant against **R.P.No.20(BC-A) in II Cycle** in A.P. Judicial Ministerial and Subordinate Service in the Unit of District Judge, Visakhapatnam, is temporarily appointed as **Field Assistant** and posted to act as Field Assistant, Principal Junior Civil Judge's Court, Yellamanchili, in the existing vacancy. Further, he is deputed to work in Senior Civil Judge's Court, Yellamanchili for attending the Nazareth and other works, until further orders.

N.B:

1. He/She is informed that his/her appointment is purely **temporary** and his/her services are liable to be **terminated** at any time without any notice or without any reason and that his/her appointment do not confer any preferential in his/her future promotions.
2. He/she is informed that his/her appointment is **subject to verification of his/her antecedents by the concerned police department**. If anything is found adverse, he/she will be terminated from service without any notice.
3. He/she is informed that the documents produced by him/her are found to have been created, manipulated, interpolated or forged in future date he/she would be removed/dismissed from the service besides launching criminal prosecution against him/her.

4. He/she shall produce **Physical Fitness Certificate** obtained from a medical practitioner of not below the rank of **Civil Assistant Surgeon** of Government Hospital at the time of joining before the Judge concerned and he/she should also submit the two sets of photo copies of all certificates (Including a copy of Employment enrolment Certificate), to the Judge concerned at the time of joining, for record.

5. He/she shall join his/her new post **on or before 05.08.2023** without fail. If he/she fails to join within the stipulated time, the offer of appointment shall be treated as automatically cancelled and the name shall be deemed to have been deleted from the approved panel.

6. He/She is further informed that the employees appointed after **01.09.2004** will be covered by the **Contributory Pension Scheme** only and that the existing Pension Scheme as per A.P. Revised Pension Rules, 1980, will not be applicable to them as per G.O.Ms.NO.653,654 and 655, Fin (Pen-I Dept) dt. 22.09.2004, issued by the Government.

7. The Nazar/Dy.Nazar of the Courts concerned are directed to provide necessary training to the newly appointed Field Assistants for a period of **one week** from the date of their joining duty, without fail.

8. He/she shall deposit the **security** in the sum of **Rs.10,000/-** at the time of his/her appointment, for the due and faithful performance of duties.

9. The undertaking form to the effect that they shall discharge the duties properly, is herewith enclosed and he/she is instructed to fill up the form properly and submit the same to the Principal District Judge, Visakhapatnam through his/her Officer.

10. He/She is informed that in view of the decision of the Hon'ble Supreme Court in Bimlesh Tanwar Vs State of Haryana and Other (2003) 5 SCC 604, seniority will be fixed as per their merit.

11. As per Circular instructions of the Hon'ble High Court, he /she is strictly instructed that he/she shall stay at their place of working and they shall not leave the Head Quarters, without permission of the Presiding Officer. Any deviation in this regard will be viewed seriously.

12. He/She informed that as per the Memorandum No.609/Ser.C/78-1, dated 06.04.1973 of General Administration (Services.C) Department, Government of A.P., as communicated by the Hon'ble High Court of A.P in ROC.No.128/2016-C-3, dated 22.01.2016, shall obtain prior permission of the Head of the Department for the employees who intend to pursue further studies.
