4.The Judges are further requested to make necessary entries of deputation of the individuals in their Service Registers and report compliance to the District Court, Visakhapatnam, without fail.

5. The above individuals shall complete all the pending works, further shall handover the charge of their posts to their successor and report compliance to the District Court, Visakhapatnam through proper channel on or before **15.09.2023**, without fail, otherwise the Judges shall not issue LPC. Any deviation of these instructions will be viewed seriously and action will be taken against the concerned as per Rules.

6. The individual at Sl.No.14 is not entitled to avail any joining time (except journey time) or to claim TTA, as his transfer/deputation is made at his request.

7.The Judges are requested not to entertain leave applications without valid grounds for the staff covered in this proceeding, if found he/she applied leave on account of this transfer/deputation, the same shall be reported to the District Court, Visakhapatnam forthwith for examination as per law.
