Any deviation of these instructions will be viewed seriously and action will be taken against the concerned as per Rules.

The Judges are requested not to entertain leave applications without valid grounds for the staff covered in this proceeding, if found he/she applied leave on account of this transfer/deputation, the same shall be reported to the District Court, Visakhapatnam forthwith for examination as per law.
