6. The individuals at Sl.No.        is/are not entitled to avail any joining time (except journey time) or to claim TTA, as his/her transfer/deputation is made at his/her request.

7.The Judges are requested not entertain leave applications without valid grounds for the staff covered in this proceeding, if found he/she applied leave on account of this transfer/deputation, the same shall be reported to the District Court, Visakhapatnam forthwith for examination as per law.
