The individuals are hereby informed that they will maintain obedience, discipline, punctuality, dedication towards Officer, staff and Office work during working hours and any deviation in this regard will lead to termination of their services at any time without assigning any reasons and without any prior intimation. The LADC Scheme is not introduced by the State and the staff for LADCS are not sanctioned by the State, the services of the individuals engaged for LADCS on outsourcing basis, such services do not come under the Rules of outsourcing staff of State. The services of the individuals engaged under LADCS are purely temporary and their services may be discontinued at any time without notice, if the NALSA instructs to discontinue the Scheme or discontinues the funding to run the Scheme.

The individuals are further directed to submit the declaration and agreement at the time of joining without fail. They will be paid remuneration depending upon the availability of NALSA Grants under LADC Scheme.

The Secretary, District Legal Services Authority, Visakhapatnam is further requested to meet the expenditure towards Honorarium payable to the above outsourcing staff for LADC, Visakhapatnam from out of NALSA grants/Funds under LADC Scheme duly following NALSA Modified LADC Scheme 2022 or as per the instructions of the Hon'ble A.P.State Legal Services Authority, Amaravathi from time to time.
