items 1 & 2 read above, applications are hereby invited
from the **Retired employees from A.P.Judicial Ministerial
Service/General Public for the post of Junior Assistant on
contract basis** in Spl. Magistrate Court, Amalapuram, East
Godavari with a consolidated Remuneration of Rs.16,400/-
per month.

The applications should be in prescribed proforma
appended hereto, to be submitted directly to the District
Court, Rajamahendravaram **on or before 22-02-2021 up to
5.00 P.M.**

**N.B: Appointment with regard to retired Judicial Employees
is subject to the following conditions for the post
of JUNIOR ASSISTANTS.**

**1) Only Persons who have retired as Junior
Assistants/Senior Assistants of A.P. Judicial
Ministerial Service will be considered for the post of
Junior Assistants.**

2) Ministerial officers who have retired on attaining
the age of superannuation and who have not attained the
age of 70 years.

3) Ministerial officers having satisfactory record of
service.

4) The candidates have to produce medical fitness
certificate and should be physically and mentally fit to
hold the post. The term of re-employment will be
determined from time to time by the High Court.


- 5) The employees who were dismissed, removed, compulsorily retired or made or made to seek retirement are not eligible for re-employment.
- 6) The employees who are re-employed shall be entitled to such consolidated remuneration as may be determined from time to time by the Government/High Court.
- 7) The re-employed shall be required to discharge their duties sincerely courteously and honestly to the satisfaction of the presiding officers.
- 8) The services of the re-employed employees are liable to be terminated at any time without assigning any reasons and without any notice and the appointment is purely temporary and on adhoc basis.
- 9) On appointment the appointees shall enter into an agreement with the concerned unit head initially for a period of one year, subject to renewal for a further period from time to time at the discretion of the unit head.
- 10) The applicants should submit their service certificates.

GENERAL PUBLIC:

- 1) The educational qualification to the General public is to pass any Bachelor Degree as per Rules in existing.
- 2) The candidates who are above 18 years of age and the candidates have not completed the age of 34 years as on 31.12.2020 are eligible for submitting their applications and five years age relaxation to the reserved categories.
