Sub:Courts – Civil & Criminal – Nomenclature of the Courts of same category functioning at the same station for trial of Civil and Criminal cases – Distribution of business of recording dying declarations among Junior Civil Judges-cum-J.F.C.Ms working at Rajamahendravaram – Instructions – Issued.

The Government of Andhra Pradesh issued orders under reference 1st cited, changing nomenclature of the Junior Civil Judge's Courts functioning in all the stations as "Junior Civil Judge – cum – Judicial Magistrate of First Class" and vice-versa. The Hon'ble High Court under reference 2nd cited, issued directions to take follow up action accordingly and same is communicated by Hon'ble District Court under 3rd reference cited. The Hon'ble District Court issued circular instructions under reference 4th cited to follow the instructions of Hon'ble High Court.

In view of the above circumstances, it is necessary to distribute the business of recording dying declarations by the Junior Civil Judges – cum – Judicial Magistrates of First Class working at Rajamahendravaram. Accordingly, the business of recording dying declarations among the Junior Civil Judges – cum – Judicial Magistrates of First Class working at Rajamahendravaram is distributed in following manner, on turn basis, month wise in rotation pattern.

2. I Addl. Junior Civil Judge – cum – I Addl. Judicial Magistrate of First Class, Rajamahendravaram.



5. IV Addl. Junior Civil Judge - cum - IV Addl. Judicial Magistrate of First Class, Rajamahendravaram. December, 2019
6. V Addl. Junior Civil Judge - cum - V Addl. Judicial Magistrate of First Class, Rajamahendravaram. January, 2020
7. VI Addl. Junior Civil Judge - cum - VI Addl. Judicial Magistrate of First Class, Rajamahendravaram. February, 2020
8. VII Addl. Junior Civil Judge - cum - VII Addl. Judicial Magistrate of First Class, Rajamahendravaram. March, 2020

The turns shall continue accordingly after the expiry of above period. If any officer is absent due to training or leave (except on casual leave) for the entire month, the next in seriatum shall attend duties so as to avoid continues burden to one officer. In case any of the officers is on casual leave the officer placed In-charge shall attend the duties. No officer shall be burdened for more than one month continuously unless there is only one officer working at the head quarters.
