- On appointment and while in service, powers conferred on a Special Magistrate of II Class can be revoked if he/she failed to attend three i) consecutive sittings of the Court without a written permission of the Chief Judicial Magistrate.
- Powers conferred by the Court on Spl. Judicial Magistrates of II Class or ii) Special Magistrate of any other category shall automatically stand withdrawn on attaining the age of 65 years.
