Sub:- District Judiciary- Certain instructions issued regarding maintaining Biometric Attendance System to all the staff members working in the District Judiciary from 01-05-2023– Further instructions issued- Regarding

Ref: 1. High Court's Circular in Roc.No.570/2023-C-1, dt.21.04.2023
2. Letter Dis.No.3245, dt.08.05.2023 from the Principal District Judge, East Godavari at Rajamahendravaram

The High Court in the Circular 1st cited, issued certain instructions to all the Principal District Judges regarding maintaining Biometric Attendance System for marking daily attendance of all the staff members including Outsourcing staff and Contract employees and also employees working at the residence of Judicial Officers (Bungalow) from 01-05-2023.

The Principal District Judge, East Godavari brought to the notice of the High Court regarding the grievances/difficulties faced by the employees working at the residence of the Judicial Officers (Bungalow) in marking their attendance through the biometric devices of Aadhar Enabled Biometric Attendance System (AE-BAS) at Court and are seeking exemption from marking Biometric Attendance at the Courts.

The High Court on considering the letter of the Principal District Judge, East Godavari and in partial modification of the High Court Circular 1st cited, hereby directs all the Principal District Judge to instruct all the Judicial Officers of their respective Units, to maintain a register at the Bungalow for marking attendance of Bungalow staff working under their control and send monthly periodical statement to the District Court for the purpose of record.
