NOTIFICATION

In exercise of the powers conferred by Article 227 of the Constitution of India and Section 477 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974) and of all other powers hereunto enabling and with the previous approval of the Governor of the State of Andhra Pradesh, the High Court of Andhra Pradesh hereby makes the following amendment to the Criminal Rules of Practice and Circular Orders, 1990.

AMENDMENT

A new Rule 30-A is incorporated in criminal Rules of Practice and Circular Orders, 1990, after existing Rule 30 of Criminal Rules of Practice and Circular Orders, 1990, as under:

"E-authenticated copies of the orders of the Hon'ble Supreme Court relating to interim orders, stay orders, bail orders and record of proceedings communicated through FASTER system shall be acted upon by all stake holders to give effect to the orders."
