It is further to inform that the Hon'ble eCommittee, Supreme Court of India is requesting all the High Courts to sensitize the Judicial Officers in this regard.

In this connection, the Member (Project Management), eCommittee, Supreme Court of India was pleased to share a copy of the statistical report of all the States in respect of cases pending for more than two years, delay reasons were not entered for more than two years and its percentage.

Therefore, I request your goodself to take immediate steps duly instructing the Judicial Officers working in your unit to update with accurate data in their respective CIS 3.2 database by taking the assistance of staff members concerned.

Further, as directed, I am to state that the above information shall be send to the undersigned on or before 25.07.2023 for onward transmission of the information received to the Hon'ble eCommittee, Supreme Court of India.

I am herewith enclosing a copy of the circular issued in the earlier occasion 2<sup>nd</sup> reference cited for your ready reference.

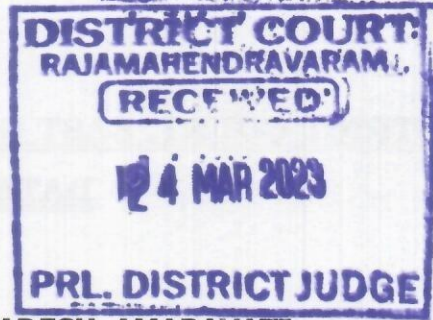

Therefore, as directed, I request all the Unit Heads to instruct the Judicial Officers working under your control to follow the bellow instructions of the Hon'ble eCommittee, Supreme Court of India;

- a) To issue direction to all the Courts under the jurisdiction of your respective District for complete and accurate data entry of Acts/Sections related to the Cases.*
- b) To issue direction to all the Courts under the jurisdiction of your respective District to make the data entry for "Reasons for delay" in all cases pending for more than two years: and to sensitize all the Judicial Officers in this regard.*

The Circular Order shall be implemented scrupulously without any deviation by completing the data entry relating to the "Acts/Sections related to the cases and for Reasons for Delay" and you are requested to ensure its compliance by 30<sup>th</sup> April, 2023.
