- 1) The above individuals are hereby directed to produce Physical Fitness Certificate in the prescribed proforma obtained from not below the rank of Civil Surgeon, at the time of joining duty.
- 2) The above individuals are hereby informed that the appointment is purely on temporary basis and is liable to be terminated at any point of time, without prior notice or without assigning any reason.
- 3) The services of the individuals will be regularized subject to his/her character and conduct being found satisfactory on verification.
- 4) The individuals are hereby directed to produce one set of Photo copies of educational qualification certificates at the time of joining duty before the Presiding officer concerned, where the individual is posted, for verification.
- 5) The individuals are hereby informed that they shall join duty of his/her post at the given station on or before 18.08.2023 without fail.
- 6) The above said individuals are informed that they will be governed under the CONTRIBUTORY PENSION SCHEME ONLY as per G.O.Ms.Nos.653, 654 & 655 Fin (Pen-I) Dept, dt.22-9-2004.
- 7) The candidates shall execute a Personal Security Bond for Rs.5 Lakhs, for a period of two years stating that they would remain in the post, at the time of joining the post, in the prescribed format.
- 8) The candidates are informed that if at all the documents produced by the candidates are found to have been created, manipulated, interpolated or forged in future date, they would be removed/dismissed from service besides launching criminal prosecution against them.
- 9) The candidates in the above proceedings who are now working in other Departments, are directed to submit Relieving Certificate from their Employer and submit the same in District Court, Rajamahendravaram, before joining duty.
- 10) The candidates are further informed that their seniority will be fixed at a later date, as per guidelines of the Hon'ble High Court.
