If the service Registers are not yet opened for new incumbents, such new incumbents should be directed to produce blank Service Registers and necessary entries should be made therein up to date and submit their particulars. The particulars of the employees who relinquished their right of promotion may also be given along with District Court's Dis. No. and Date. by mentioning the employee belongs to OC, BC, SC, ST and Physically Handicapped.

The Chief Administrative Officers/Superintendents/In-charge Superintendents of the Courts should certify the correctness of the particulars furnished and also should obtain the signature of the concerned employee against the particulars about their correctness.

Further, some of the Chief Ministerial Officers of the Court are submitting the information without verifying the service registers of the individuals. If any incorrect information and omissions will found in submitting the above information, the Chief Ministrerial Officer of the Court will be held responsible for the same.

The above said information should be submitted to the District Court, East Godavari, Rajamahendravaram by 10/10/2023 positively.
