Pursuant to the G.O. and High Court's Letters references 1 & 2 read  
above, applications are hereby invited from the **Retired employees from  
A.P.Judicial Subordinate Service and Outsiders** for **ONE post** of  
Attender in Special Magistrate Court, Amalapuram (Civil Judge - Junior  
Division) on Contract Basis in the Unit of the District Judge, East Godavari  
with a consolidated Remuneration of Rs.20,000/- per month.

The applications should be in prescribed proforma appended hereto,  
to be submitted directly to the District Court, Rajamahendravaram **on or  
before 31-10-2023 up to 5.00 P.M.**

**N.B: Appointment with regard to retired Judicial Employees is subject  
to the following conditions for the post of ATTENDER (On  
Contract basis).**

- 1) **Only Persons who have retired in the cadre of Office  
Subordinates of A.P. Judicial Ministerial and Subordinate Service  
will be considered for the post of Attender (On Contract basis).**
- 2) Office Subordinates who have retired on attaining the age of  
superannuation and who have not attained the age of 70 years.
- 3) Office Subordinates having satisfactory record of service.
- 4) The candidates have to produce medical fitness certificate and  
should be physically and mentally fit to hold the post. The term of re-  
employment will be determined from time to time by the High Court.

- 5) The employees who were dismissed, removed, compulsorily retired or made or made to seek retirement are not eligible for re-employment.
- 6) The employees who are re-employed shall be entitled to such consolidated remuneration as may be determined from time to time by the Government/High Court.
- 7) The re-employed shall be required to discharge their duties sincerely courteously and honestly to the satisfaction of the presiding officers.
- 8) The services of the re-employed employees are liable to be terminated at any time without assigning any reasons and without any notice and the appointment is purely temporary and on adhoc basis.
- 9) On appointment the appointees shall enter into an agreement with the concerned unit head initially for a period of one year, subject to renewal for a further period from time to time at the discretion of the unit head.
- 10) The applicants should submit their service certificates.
- 11) If retired employees are not available, the outsiders will be considered and they must have pass 7<sup>th</sup> Class Examination or its equivalent examination. Candidates who failed "Intermediate or equivalent examination" will be considered eligible, but those who have higher qualifications than that shall not be considered eligible.
- 12) Age Limit: Age 18 to 42 years as on 01.07.2023 and relaxable by 5 years in respect of persons under SC, ST, BC and EWS to the outsiders.
