3. Rates should be quoted in figures and words clearly inclusive of all.
4. The sealed tender must be addressed to the Principal District Judge, East Godavari at Rajamahendravaram and super scribed as Tender for supply of Biometric Attendance systems. No responsibility will be taken for postal delay or non delivery non receipt of tender documents. Tender received after the stipulated time and date or incomplete in any respect shall not be considered and will be summarily rejected. Conditional tenders are liable to be summarily rejected.
5. The Principal District Judge, East Godavari, Rajamahendravaram will carefully examine the tender document and may request such firms which fulfill the technical specifications as per the requirements of the tender for arranging demonstration of their equipment.
6. No consortium will be allowed.
7. The prospective bidder should have experience in the business of having completed similar works pertaining to supply and installation of biometric attendance systems.
8. The rates are for free delivery of the items at Principal District court East Godavari, Rajamahendravaram.
