#### MINIMUM EDUCATIONAL QUALIFICATIONS:

To pass  $7^{th}$  Class or  $10^{th}$  Class Examination for the post of Court Attendant.

The candidates who are having higher qualification than that of  $10^{\rm th}$  class are not eligible.

- 3) Any employee who has taken voluntary retirement on the ground of medical invalidation, retired on compulsory retirement from service, dismissed or removed from service shall not be eligible for appointment of Court Attendant.
- 4) Service Certificate should be submitted along with application duly obtained from the officer last worked.
