Pursuant to the references 1st to 6th read above, applications are hereby invited from the following qualified:

- 1) Judicial Employees of A.P. Judicial Ministerial Service who have retired as Typist cum Assistant and who are proficient in Typewriting and having requisite qualifications for appointment as Typist cum Assistant will be considered for the Post of Typist-cum-Assistant.
- 2) Outsiders who are having Bachelor Degree or its equivalent qualifications and Typewriting in English Higher grade, if such persons are not available Lower grade will be considered and having Computer Knowledge, between age group of 18 to 65 years as on 01.07.2024.

To fill up **01 post of Typist-cum-Assistant on Contract Basis** in Permanent Lok Adalat for Public Utility Services, Rajamahendravaram.

The applications should be in the prescribed proforma appended hereto, to be submitted directly to the Chairman-cum-Prl. District Judge, District Legal Service Authority, East Godavari District at Rajamahendravaram on or before 28.11.2024 upto 5.00 P.M. by mentioning on the top of the envelop as to the post for Typist cum Assistant.

N.B:-The Appointment of retired Judicial Employees/normal candidates is subject to the following conditions for the post of Typist Cum Assistant.

- 1) The persons who have retired as Typist cum Assistant of A.P. Judicial Ministerial Services and the candidates who are proficient in type writing and have requisite qualification for appointment as Typist will be considered for the post of Typist.
- Ministerial Officers who retired on attaining the age of superannuation and who have not attained the age of 65 years.
- 3) Ministerial officers having satisfactory record of service.
- 4) The candidates have to produce medical fitness certificate and should be physically and mentally fit to hold the post. The term of re-employment will be determined from time to time.
- 5) The employees who were dismissed, removed, compulsorily retired or made to seek retirement on medical grounds are not eligible for re-employment.
- 6) The employees who are re-employed shall be entitled to such consolidated remuneration as may be determined from time to time by the Government/High Court.
- 7) The re-employed shall be required to discharge their duties sincerely courteously and honestly to the satisfaction of the presiding officers.
- 8) The services of the re-employed person is liable to be terminated at any time without assigning any reasons and without any notice and the appointment is purely temporary on contract basis.
- 9) On appointment the appointees shall enter into an agreement with the concerned Unit Head initially for a period of one year, subject to renewal for a further period from time to time at the discretion of the Unit Head.
- 10) The retired employees should submit their service certificates.

Copies of documents only (but not the originals) to be enclosed to the application duly attested.

- 1. Certificates of Academic qualifications, Marks list of the Qualifying examination viz. S.S.C. or equivalent examination and other certificates to prove their proficiency and skills, if any.
- 2. Certificate showing the date of birth.
- 3. Community Certificate
- 4. Employment Registration Card.
- 5. A self addressed postal envelope affixed with sufficient Postal stamps.
- 6. Two recent passport size photos

7. In case of physically handicapped, a certificate should be enclosed to that effect.

NB:-

- 1.Incomplete applications or applications without the required attested copies of documents as mentioned above will be summarily rejected.
- 2. The applications received in any other format will be summarily rejected.
- 3. Applications are liable to be rejected at any stage, if any information furnished therein is found to be false and the applicants are liable for prosecution for furnishing false information.
- 4. Appointment will be made only on the basis of the Presidential Order issued under Art.371-D of the Constitution of India subject to rules of reservation.
- 5.After short listing, the candidates are liable to be subjected to such written tests as may be though necessary, for testing their suitability to the post applied for like ability to read and write, grasping power, proficiency in the subject and special qualifications etc, besides interviewing the candidates by the undersigned orally.
- 6. Candidates shall be disqualified for appointment if he/she herself or through relations or friends or any others has canvasses or endeavored to enlist for him/her candidature, extraneous support from Official or non-official source for appointment to the post notifies as per rule 12 (2) (d) of the A.P.State and Subordinate Service Rules, 1996.

- 8. The candidate is to be of sound health, active habits and free from bodily defects of infirmity, otherwise making her unfit for the service.
