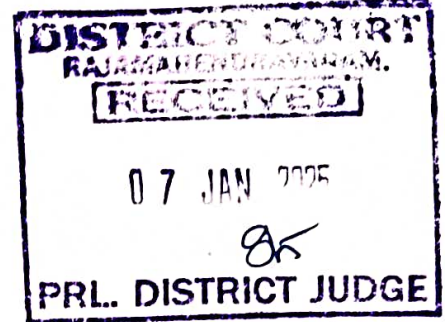

**ORDER:**

In the reference 5<sup>th</sup> read above, the Additional Director General of Police, Crime Investigation Department, Andhra Pradesh, has informed

that the notifications issued in the references 1<sup>st</sup> to 4<sup>th</sup> cited and earlier notifications are not in accordance with the spirit of the Prevention of Corruption Act, 1988 (Central Act, No.49 of 1988). The name of the Court and the area has to be prescribed as in the Prevention of Corruption Act, 1988.

2. The Government of Andhra Pradesh, under sub-section (1) of section 3 of the Prevention of Corruption Act, 1988 (Central Act, No.49 of 1988) hereby notify the Jurisdiction of the Special Courts, for trial of the offences under the Prevention of Corruption Act, 1988 in the State of Andhra Pradesh. (Erstwhile Districts before 03.04.2022).

3. Accordingly, the following notification will be published in the Extraordinary issue of the Andhra Pradesh Gazette, dated:09.12.2024.

### NOTIFICATION

*In exercise of the powers conferred by sub-section(1) of section 3 of the Prevention of Corruption Act, 1988 (Central Act, No.49 of 1988), and in modification of the earlier Notifications issued on the subject, the Government of Andhra Pradesh, hereby specifies that the Special Court for trial of Cases under the Prevention of Corruption Act, 1988, the Crime Investigation Department, Andhra Pradesh, shall have and exercise the jurisdiction over the Anti - Corruption Bureau Ranges and the Judicial Districts shown in Column (3) thereof under the said Act, 1988.*
