Sub: **Direct Recruitment** – Direct Recruitment to the posts of Examiners under the Andhra Pradesh Judicial Ministerial and Subordinate Services in the unit of District Judge, East Godavari – Appointments and Posting orders – Issued.

The Hon'ble High Court of Andhra Pradesh issued Notification 1st read above and invited on-line applications to fill up the posts of Examiners in the unit of Principal District Judge, East Godavari. Further, computer based examinations were conducted from 20.08.2025 to 24.08.2025 and published the list of candidates who provisionally selected to the post of Examiners 2nd read above. The Hon'ble High Court under item 3rd read above further instructed the provisionally selected candidates to produce their original certificates and other documents before the Principal District Judge, East Godavari from 19-01-2026 to 23-01-2026. Certain provisionally selected candidates for the post of Examiners have appeared before the Office of the Principal District Judge, East Godavari and submitted their original educational qualification certificates etc., and Revised Attestation Forms.

In pursuance of the instructions of the Hon'ble High Court 3rd read above and upon perusing the Original certificates of the individuals, the Principal District Judge, East Godavari at Rajamahendravaram is pleased to make the following:

N.B.:-

1) The above individuals are hereby directed to produce Physical Fitness Certificate in the prescribed proforma obtained from not below the rank of Civil Surgeon, at the time of joining duty.

2) The above individuals are hereby informed that their appointment is purely on temporary basis and is liable to be terminated at any point of time, without prior notice or without assigning any reason.

3) The services of the individuals will be regularized subject to his/her character and conduct being found satisfactory on verification.

4) The individuals are hereby directed to produce one set of Photostat copies of educational qualification certificates at the time of joining duty before the Presiding officer of the Court, where the individual is posted, for verification before the Presiding Officer of the Court.

5) The individuals are hereby informed that they shall join the duty of his/her post at the given station on or before **02-02-2026**, otherwise, the orders will be invalidated.

6) The above said individuals are informed that they will be governed under the CONTRIBUTORY PENSION SCHEME ONLY as per G.O.Ms.Nos.653, 654 & 655 Fin (Pen-I) Dept, dt.22-9-2004.

7) As per APJMSS Rules issued in G.O.Ms.No.76 Law (L, LA &J Home Courts.A) Department, dated 15-05-2019, all the individuals have to deposit security for an amount of Rs.10,000/- for the due and faithful performance of his/her duties, within a month from the date of his/her appointment and produce the same before the office.

8) The candidates are informed that if at all the documents produced by the candidates are found to have been created, manipulated, interpolated or forged in future date, they would be removed/dismissed from service besides launching criminal prosecution against them.

9) If any candidates are working in other Departments, they are directed to submit Relieving Certificate from their Employer and submit the same in Principal District Court, Rajamahendravaram, before joining duty.

10) The candidates are further informed that their seniority will be fixed at a later date, as per guidelines of the Hon'ble High Court.

11) The individuals are not entitled to any deputation allowance.

12) The downloaded copy of orders from the Official website of e-Courts, East Godavari is valid to permit the new incumbents to join duty.
