Important Instructions to the candidates

1. Candidates shall bring Blue/Black Ball pen for the examination. No stationery items will be provided.
2. Candidates shall produce their Hall Ticket at the Entrance of the Examination Centre and also in the Examination Hall/Room, failing which the candidates will not be allowed to write the examination. The candidates shall sign the attendance sheet in the Examination Hall.
3. Candidates will be permitted to appear for the Test, after their credentials are verified by the centre officials and after frisking to ensure that no prohibited articles are carried (**Purses, writing pads and hand bags are not allowed**). At the examination centre, the Authority will not make any arrangements for safe custody of any articles/things carried by the Candidates, and they shall make their own arrangements.
4. The Hall Ticket must be presented for verification along with **atleast one Original valid identification card i.e., Passport, Pan Card, Voter ID, Aadhar Card, Govt.Employee ID or Driving License etc.,**
5. **If any candidate received the hall ticket without photo/too small photo, Photo without signature (or) did not receive hall ticket due to postal delay, the candidate should download the empty hall tickets (2) from District Court website, affix two passport size photos duly attested by the Gazetted Officer and hand over the same to Invigilator in the examination hall at the reporting time of examination, this Authority will issue hall ticket to the candidate at the examination centre, failing which the candidate will not be admitted to the examination.**
6. The list of Hall Tickets dispatched to all the eligible candidates will be displayed in **District Court website, East Godavari**. Hence, all the candidates are requested to visit the website of District Court, East Godavari District to keep themselves abreast on all the related notifications until the completion of the recruitment. No separate information will be provided in this connection in any other mode.
7. Candidates will be allowed into the Examination centre from the reporting time, as the candidates have to undergo procedural formalities which are required for the examination. The test centre gates will be closed as per the time mentioned in the Hall Ticket. **No candidate will be allowed to enter the Test Centre after closing of the gate.**
8. Candidates are not allowed to bring any electronic devices such as Mobile/Cell phones, programmable calculators, Tablets, I-pad, Blue-Tooth, pagers or any other device capable of interacting/programming to the examination centre. Any violation of the above leads to disqualification of the candidature.
9. Candidates are expected to behave in orderly and disciplined manner while taking the examination. The candidature will be rejected in case of impersonation, disorder/Rowdy behaviour during examination. Necessary FIR for the incident will be lodged with concerned Police Station apart from disqualifying the candidature. The Centre Chief invigilator is duly authorized to take spot action in such cases.
10. Candidates are prohibited from communicating, consulting or conversing with other candidates in the Examination Hall or causing disturbance in any manner whatsoever. Candidates are prohibited to borrow any item from other candidates in the Examination Hall. In case of any disturbance, such candidates would be disqualified.
11. Frequent visits to toilet are not permitted. Candidates advised to use the toilet facility only in case of extreme necessity. If any candidate is found to be indulged in discussions or malpractice near the toilets or corridors of any other places, they would be disqualified.
12. Candidates are requested to be remain in their seat and not to look into the others papers except the paper allotted to the candidate. If any candidate or candidates are found to be peeping or glancing into others papers of other candidates, they would be disqualified.
13. The total duration of examination for the Post of Record Assistant and Front Office Coordinator is 90 minutes and the duration of examination for the Post of Data Entry Operator is 60 Minutes.
14. No Names or any other matters will not be written on Question Paper.
15. Violation of any of the instructions may lead to invalidation of the candidature besides penal action.
