Sir/Madam,

Reference is invited to ibid subject. As you aware that considering the ongoing Covid-19 pandemic, the courts are functioning in virtual mode through CISCO Webex and the dedicated Enterprise Version licences have already been provided to all the existing courts.

In order to facilitate the lawyers and litigants, the static IPs/links of CISCO Webex have been created for all the courts and made available on the official website and the same has to be made operational on daily basis by the staff official of the respective court.

It may be noted that considering the frequent complaints being received from the lawyers that on joining the static IPs/links of CISCO Webex of some of the courts the screen of their hardware shows "Notify Host" and such message flashed only due to non-functioning/operational static IPs/links of CISCO Webex. Considering such complaints, the static IPs/links of CISCO Webex of courts functioning in Central District were checked randomly at about 11.10 a.m on 07.07.2021 by the learned Principal District & Sessions Judge (HQs) and it has been noticed that some of the courts have not started the court hearings till the time.

Needless to say, non-adhering to the court hours may cause undue hardship to the lawyers and litigants so also put hurdle in smooth and hassle-free functioning court establishment, a serious view has been taken by learned Principal District & Sessions Judge (HQs) and has been pleased to request you to adhere to the court hours and to issue necessary directions to the staff official of respective court to start the court hearings in virtual mode through static IPs/links of CISCO Webex as provided/displayed on the official website from 10:00 am positively and remained keep it live/functioning till rising of the court, without fail else the office would be constrained to take disciplinary action against the erring official.
