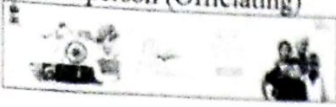


It is requested that the nominated Principal Magistrates posted in your district may kindly be communicated about their nomination through your good office.


