ORDER

In pursuance of Minutes of the Meeting of Hon'ble State Court Management Systems Committee dated 04.02.2020 and in partial modification to this office order No. 2719/87297-332/F.3(4)/AD&SJ/Gaz/2019 Dated 06.12.2019, No.43/1294-338/F.3(4)/AD&SJ/Gaz/2020 Dated 09.01.2020, No.84/2563-2602/F.3(4)/AD&SJ/Gaz/2020 Dated 15.01.2020 & No.203/5603-5638/F.3(4)/AD&SJ/Gaz/2020 Dated 24.01.2020, it is clarified that only those cases instituted on or after 03.05.2018 which fall within the definition of "Commercial dispute" as defined in Section 2(1)(c) of the Commercial Courts Act, 2015 shall be entertained by the Courts of District Judge (Commercial Court).

In view of the directions contained in the aforesaid minutes, all the Additional District Judge of Central District are requested not to transfer the Commercial Cases which were registered prior to 03.05.2018 to the Court of District Judge (Commercial Court) (Central) Tis Hazari Courts, Delhi. Furthermore, the cases instituted prior to 03.05.2018 pending in the Courts of District Judge (Commercial Court) (Central) Tis Hazari Courts, Delhi, the same are hereby withdrawn and transferred back to the Courts from where the said cases were received.
