As per directions of Hon'ble High Court of Delhi, New Delhi, the Courts shall hold regular physical Courts, on a daily basis, as per regular Court timings w.e.f. 15.03.2021 and shall take up all cases fixed before them. The Judicial Officers are impressed upon to take up cases in which UTPs are produced as per the optimum capacity of the lock-ups on priority, where the accused is in custody for a considerable period.

Further, the Court may, in exceptional cases, permit any of the parties and/or their counsel to join the proceedings through Video Conferencing, subject to availability of requisite infrastructure.

The Advocates, litigants and other visitors to the Courts shall strictly adhere to the norms of social distancing and all other Covid-19 protocols, guidelines, directions, etc. issued by the Government of India, Govt. Of NCT of Delhi and Hon'ble High Court of Delhi from time to time.

The guidelines/SOPs issued by the Ld. Principal District & Sessions Judge (HQs), Delhi w.r.t. to opening of entry gates/exit points, mandatory use of "Arogya Setu" application, running of the Facilitation Centre, operation of the lock-up, parking of vehicles, closure of the Courts Complex, provision with regrd to medical facilities to the Judicial Officers/Court Staff, service of Notary Officers & Oath Commissioners etc, shall be adheared to which guidelines/SOPs have been framed in consultation with the Office bearers of the Delhi Bar Association.
