In wake of the regular physical hearings of the cases in the Courts with effect from 22-11-2021, and in supersession of this office order No. 5323-5381/CMM(West)DR/THC/2021 dated Delhi 16-09-2021, as verbally approved by the Ld. CMM(West) Delhi, it is hereby ordered that whenever any Metropolitan Magistrate of West District Delhi is on leave or unavailable due to official work, each Ld. MM(Reliever) District West Delhi, shall look after the court work of only two courts, as link MM, as per the table A, Rest of the condition shall remain unchanged as mentioned in the order No. 5323-5381/CMM(West)DR/THC/2021 dated Delhi 16-09-2021

In case more than two Metropolitan Magistrates happens to be on leave, the work of remaining Courts, on leave shall be looked after by the regular MMs of West District Delhi as per the table B. The first two courts are to be decided by Ld. MM (Reliever) on first come basis.



Note:

- 1) Whenever any MM is on leave or is not available due to any reason, and Ld. MM(Reliever) West Delhi is already looking after work of two court, his/her work shall be looked after by the link magistrate shown against his / her name in the opposite column as per table B. In case both the said MMs are on leave or not available for similar reason, the MMs whose name is mentioned immediately below the name of the MM concerned shall work as next link MM and shall look after the work of court of MM whose name finds mentioned above his/her name. In case even the next link MM mentioned immediately below the name of concerned MM is on leave or somehow not available, the MM whose name finds mentioned immediately below thereafter shall work as next link MM for such duration and so on and so forth. The two MMs mentioned in the last horizontal line in table B shall be deemed to be MMs placed immediately above the two MMs mentioned in the first horizontal line in the table B.
- 2) Sh. Navdeep Gupta, Ld. MM(Reliever) West District Delhi shall be first Link MM of Ms. Chhavi Kapoor, Ld. CMM West Delhi, as and when she is on leave or otherwise busy with the administrative work or not available, In the absence of Sh. Navdeep Gupta, Ld. MM(Reliever) West District Delhi, Sh. Aakash Sharma Ld. MM shall look after the court work of Ld. CMM. West Delhi and in the absence of both judicial officer the same shall be looked after by the Duty MM of the day.
- 3) Ms. Karuna Ld. MM(Reliever) West District Delhi shall be first Link MM of undersigned as and when undersigned is on leave or otherwise busy with the administrative work or not available. In the absence of Ms. Karuna Ld. MM(Reliever) West District Delhi, Sh. Abhinav Pandey, MM shall look after the work of undersigned and in the absence of both judicial officer the same shall be looked after by the Duty MM of the day.
- 4) In the absence or non availability of Ld. CMM(West) Delhi being on leave or otherwise busy, the administrative work of the office of Ld. CMM(West) Delhi shall be looked after by the undersigned and in the absence of undersigned this part of the works shall be dealt by Sh. Rakesh Kumar-II, Ld. MM and in the absence of Sh. Rakesh Kumar-II, Ld. MM the said work shall be looked after by the Duty MM of the Day.
- 5) Sh. Mohit Sharma, Ld. MM(Digital Court -01) West District Delhi and Ms. Chhaya Tyagi, Ld. MM(Digital Court-02) are the Link MM of each other court. In case both the Metropolitan Magistrate of Digital courts are on leave the court work of digital court of West District shall be placed before the Ld. CMM/West/ Delhi/undersigned/Duty MM of the day for marking it further.
- 6) It is clarified that the Metropolitan Magistrates(Reliever) West Delhi shall look after the work of the link duty, TIP, Inquest Proceedings recording of statements Under Sec. 164 Cr.P.C. besides administrative duties as per order No. 71/DHC/Gaz./VI.E 2(a) 2020 dated 18-11-2020.
