


OFFICE OF THE CHIEF METROPOLITAN MAGISTRATE DISTT. WEST : THC : DELHI

-: ORDER :-

This is with reference to office order bearing no. 123/RG/DHC/2021 dated 20-02-2021 of the Hon'ble High Court of Delhi, New Delhi and in partial modification of this office earlier order bearing no 813-867/CMM(West)/THC/2021 dated 19-12-2021 and 868-922/CMM(West)/DR/THC/2021 dated 19-02-2021, it is impressed upon all the Metropolitan Magistrates and Metropolitan Magistrates (Reliever) of the West District, Tis Hazari Courts Delhi that they shall hold **regular Physical Courts, on daily basis**, as per regular timings w.e.f. 15-03-2021 and shall take up all cases fixed before them. The Metropolitan Magistrates of West District are also impressed upon to take cases in which UTPs are produced as per the optimum capacity of the lock-ups on priority, where the accused is in a custody for a considerable period.

Further, the court may, in exceptional cases permit any of the parties and /or their counsel to join the proceedings through Video Conferencing, subject to availability of requisite infrastructure.

The Advocates, litigants and other visitors to the courts shall strictly adhere to the norms of social distancing and all other Covid 19 protocols, guidelines, directions, etc. issued by the Government of India, Govt. of NCT of Delhi and Hon'ble High Courts of Delhi from time to time.


