Principal District & Sessions Judge (Hqs), Delhi w.r.t. to opening of entry gates/exit points, mandatory use of "Arogya Setu" application, running of the Facilitation Centre, operation of the lock-up, parking of vehicles, closure of the Courts Complex, provision with regrd to medical facilities to the Judicial Officers/Court Staff, service of Notary Officers & Oath Commissioners etc, shall be adheared to which guidelines/SOPs have been framed in consultation with the Office bearers of the Delhi Bar Association.
