ROASTER FOR HOLIDAYS FOR THE MONTH OF APRIL 2022

As verbally approved by the Hon'ble Principal District and Sessions Judge West Delhi, for the smooth functioning of the Magisterial Court of West District, Delhi, it is ordered that in order to ensure norms of social distancing, two Ld. Metropolitan Magistrates of West District are deputed as Duty MMs on holidays in the month of April 2022 who will work as Duty Magistrate-I and Duty Magistrate-II on the dates noted against their names. The regular Duty MM of the day will be termed as Duty MM-I and Additional Duty MM will be called as Duty MM-II. The Ld. Duty MMs are required to reach to court by 11.00 a.m. and remain there up to 5.00 p.m. or till the disposal of remand and other misc. work whichever is later. On holidays the work shall be divided as per the following schedule:-

1)In addition to aforesaid work, if any other matter of urgent nature is received on holidays 1)In addition to allow the same shall be looked after by the Duty after court hours and before 10 am of next day, the same shall be looked after by the Duty MM-I.

- 2) It is clarified that on working days, all the Bail applications & Superdari Applications shall have to be heard by the concerned court.
- 3) Bail applications/ Superdari applications may be sent to the concerned area MM /duty MM at email id of the said court as per Annexure " A".
- 4) Application under 200 Cr.P.,C./D.V.Act/Execution may be sent to the concerned area MM at email id of the said court as per Annexure "A".
- 5) Every fresh application should contain mobile number/email id of Ld. Counsels/litigants.
- 6) All the Ld. MM(s) shall comply the directions received from time to time regarding disposal of the work from Hon'ble High Court of Delhi and from Ld. District & Sessions Judge (West), Delhi.
- 7) The Ld. MMs deputed for duty and the staff of their courts who will work on Holidays will be entitled to avail Special Casual Leave (Compensatory Leave) in lieu of the duty performed on such day (s) as per rules. The special casual leave (compensatory) of the MMs shall be routed through and after verification by the undersigned. The MMs while forwarding the application of the staff for grant of such special casual leave (compensatory) shall verify that the official concerned had actually worked on a particular date.
- 8) All the MMs are directed to strictly comply with the directions passed by the Hon'ble High court of Delhi in W. P. (Crl.) 861/1997 titled U.S.Pandey, President of W.A.S. Vs. U. O. I. & Ors while performing their duties as Duty M.M.
- 9) It is clarified that on holidays, if one Duty MM(of one group) is assigned a number of statements u/s 164 Cr.p.c. for recording and he/she is held up in recording statements u/s 164 Cr.p.c. whereas the other Duty MM (of the other group) is free to record the statement, then the First Duty MM shall be at liberty to mark the statement to the second Duty MM to record the same, so that the witnesses are not kept waiting in the court complex.
- 10) When any working day is declared a holiday, the Duty Magistrate on that day will be deemed as Duty Magistrate for whole day without any further order.
- 11) In case of emergency the Duty Magistrate is not available due to some inevitable reasons he/she will send a formal request one day in advance for change of duty alongwith the written consent/willingness of the officer agreeing to perform duty in his/her place, to the office of the undersigned.
- 12) The Judicial Officer who are deputed as Duty Magistrate, if summoned for the day of such duty to appear as witness in a court located in court complex other than the place of posting will send a formal request in advance to the court where he/she has to appear as a witness for his/her exemption from court attendance for that date, he /she may do so in the forenoon session, under intimation to the undersigned (Ref: standing order issued by the Ld. District Judge-I & Sessions Judge, Delhi. Video NO. 42534-684/DM/Gaz. Dated 26-10-1999.
- 13) In case, if any information regarding Inquest U/ 176 Cr.P.C. is received between 10.00 A.M to 5.00 P.M on a working day, the application for the same shall be moved before the undersigned/Ld.ACMM/Ld. Duty MM of the day for marking it further.
- 14) It is clarified that on working day, if any Inquest information is received by the Duty M.M after 05.00 P.M till 9.59 A.M.on the immediate succeeding day, then the same shall be deemed to be marked to the concerned Duty M.M of the day, who shall proceed to conduct the inquest proceedings and no formal marking of such Inquest by the undersigned shall be required.
- 15) If any inquest information is received by the Duty Metropolitan Magistrate-I West district, Delhi on holiday, then the same shall be deemed to be marked to the Duty M.M.-I of the day, who shall proceed to conduct the inquest proceedings and no formal marking of such Inquest by the undersigned shall be required.
