

1. The Courts, shall however, permit hybrid/video conferencing hearing where a request to such effect is made by any of the parties and / or their counsel.
2. As there are only three MMs(Reliever) are left in the West District and one or two MMs (Reliever) have to go to conduct TIP on daily basis. Thus there would be shortage of MMs (Reliever), if they are called on alternate days. Therefore, MMs. (Reliever) shall attend the Court on daily basis, (except holidays).
