- 01 On non-physical days, every Judicial Officer shall hold court through virtual mode.
- 02 Endeavour shall be made to take up stay applications, bail application and other urgent miscellaneous urgent maters on physical days, wherever request to such effect is made.
- 03. On physical hearing days, the courts shall, wherever possible, permit hybrid/video-conferencing hearing where a request to such effect is made by any of the parties and/or their counsel.
- 04. During physical hearings, the Ld. Metropolitan Magistrate of West District, Delhi shall give up priority to those cases where the accused are in custody as well as to 5 years old cases.
- 05 As there are only three MMs (Reliever) are left in the West District and one or two MMs (Reliever) have to go to conduct TIP on daily basis. Thus there would be shortage of MMs(Reliever) if they are called on alternate days. Therefore, MMs (Reliever) shall attend the Court on daily basis (except holidays).
