Mr. Sandeep Goel, DG (Prisons) has submitted data compiled with regard to the "Inmate Population" in each jail of the Central Jails Complex including Rohini and Mandoli Jail.

After detailed discussion on the issues concerning remand of fresh accused persons as also Under Trial Prisoners (UTPs), the following decisions are taken:-

- 1. Fresh cases of production of accused persons under the provisions of IPC and/or General Laws as also Special Enactments viz., Protection of Children from Sexual Offences Act (POCSO); The Unlawful Activities (Prevention) Act; Maharashtra Control of Organised Crime Act; Narcotic Drugs and Psychotropic Substances Act; Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act for all the districts in Delhi shall be dealt with by the Jail Duty MMs designated for the said purpose physically in the Tihar Jail Complex.
- 2. It is further provided that at least three Jail Duty MMs shall be deputed for the said purpose and the said disposition may be modified or altered depending upon the volume of work that may be dealt by the Jail Duty MMs. The strength may be increased by the learned CMM (Central) in consultation with all other learned CMMs of Delhi.

- 3. The accused persons booked under the special enactments shall be produced for subsequent remands before the concerned court(s) in the respective districts through video-conferencing by the jail authorities for appropriate legal proceedings.
- 4. The Under Trial Prisoners (UTPs) in cases under the IPC and/or General Laws irrespective of whether charge-sheet/final police report has been filed or not filed shall be produced on the date of hearing for further remand through video conferencing before the concerned Duty MMs of the concerned district.
- It shall be incumbent upon the Investigating Officer to produce the case diary as also police file where the matter is under investigation and chargesheet/police report has not been filed.
- 6. Further, the IOs shall produce the same before the concerned duty MMs of the district strictly as per the time slots allotted to the jail authorities for production of such accused through video-conferencing. The time slots or scheduled time frame shall be decided by the learned CMM (Central) in consultation with his brethren CMMs of the other districts and shall be intimated to the DG (Prisons) as also various police districts through the Joint Commissioner of Police (Law & Order), Delhi.
