Sub.: Option for Environment Awareness & Stress Management Retreat

Respected Sir/Madam,

As you are aware that Delhi Judicial Academy has been organizing Environment Awareness and Stress Management Retreats every year with the broad objective of Awareness / Exposure and Stress Management. However, due to COVID Pandemic situation, such retreats could not be organized for some time.

In view of the improvement in COVID situation, the Academy intends to conduct one such Retreat Programme to Chail, Himachal Pradesh from 10th to 12th December, 2021.

As per the criteria for nomination of participants for the retreats, each Judicial Officer of DHJS & DJS (*except those on 'Deputation', working in Organizations /Departments which are not under the control of the High Court of Delhi*) shall be nominated to participate in the retreat. Number of participants for such retreat will be 55 to 60 Judicial Officers.


Needless to mention that the retreat would be conducted subject to approval of Hon'ble High Court and upon review of the Pandemic situation prevailing at the time of visit.

It is, therefore, requested that the Judicial Officers posted in your district may kindly be asked to send their option to the Delhi Judicial Academy. Once the option is exercised, the concerned Judicial Officer may not be permitted to withdraw the same except under compelling circumstances. The Judicial Officers who had participated in the retreat in the year 2019 may not send their option for this year's programme.

Since, the retreat is scheduled to be held on 10th – 12th December, 2021, all the officers may be requested to send their option by 16th October, 2021 positively so as to enable us to make necessary preparations well in advance.
