Sub.:- Regarding Guidelines.

Sir/Madam,


It is hereby informed to all the Learned Judicial Officers of District Courts, Delhi (including Judicial Officers on Deputation as well as Trainee Judicial Officers) that Court Library Books, Bare Acts, Bound Volumes/Loose Parts of the Law Journals "Apex Decisions (Supreme Court)", "Apex Decisions (Delhi High Court)" and other Law Journals, etc. are under the custody of the Reader of the respective Courts and they are not the part of Residential Library of the Judicial Officers. No Judicial Officers is allowed to take Court Library Books, Bare Acts, Bound Volumes/Loose Parts of the Law Journals "Apex Decisions (Supreme Court)", "Apex Decisions (Delhi High Court)" and other Law Journals, etc. along with them on their transfer from the Court. If any Judicial Officers have Court Library Books, Bare Acts, Bound Volumes/Loose Parts of the Law Journals "Apex Decisions (Supreme Court)", "Apex Decisions (Delhi High Court)" and other Law Journals, etc., then they should return it back to the Reader of the respective Court. Further, if any Judicial Officers have taken with them the Court Library Books, Bare Acts, Bound Volumes/Loose Parts of the Law Journals "Apex Decisions (Supreme Court)", "Apex Decisions (Delhi High Court)" and others Law Journals, etc. on their transfer, then they should immediately return back the Books/Bare Acts/Law Journals (Bound Volumes/ Loose Parts), etc. to the Reader of the concerned Court.
