Circular / Duty Roster

This is with reference to order bearing no. R-77/RG/DHC/2020 dated 15.04.2020 of Hon'ble High Court of Delhi vide which it is ordered that the functioning of the Courts subordinate to Hon'ble Delhi High Court shall continue to remain suspended till 03.05.2020 on same terms as contained in their earlier office order no. 373/Estt./E1/DHC dated 23.03.2020 and no. 159/RG/DHC/2020 dated 25.03.2020.

Accordingly, keeping in view of the directions of the Hon'ble High Court of Delhi this order is issued in continuation of this earlier office Order dated 28.03.2020. Now, the following Rosters of Ld. ASJ's and ADJ's respectively are hereby laid down for exercise of various jurisdictions in the West District till 02.05.2020 (03.05.2020 being Sunday) and in exercise of powers vested with the District & Sessions Judge (West) inter alia under Section 10(3) Code of Criminal Procedure 1973 as in force in Delhi, I hereby authorize the following Additional District & Sessions Judges of West District to hear and dispose of remands as well as Bail applications in pending as well as fresh cases / urgent Criminal applications (police stations of West District as mentioned below) including those under Special Acts i.e. the Narcotics Drugs and Psychotropic Substances Act, 1985, the Terrorist and Disruptive Activities (Prevention) Act, 1987, the Prevention of Terrorism Act, 2002 and the Maharashtra Control of Organized Crime Act, 1999, Protection of Child Rights Act, 2005, Protection of Children from Sexual Offences Act, 2012 and Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 pertaining to the West District Sessions Division and in exercise of powers vested with the District & Sessions Judge (West) inter alia under Section 21-A of the Punjab Courts (Delhi Amendment) Act, 1997, to exercise all the powers to distribute the business as vested in me for West District under section 34 of the Punjab Courts Act, 1918, I hereby authorize the following Ld. District Judge (Commercial) and Additional District Judges pertaining to the West District Civil Division during the period as mentioned below :-

Note :

1. The matters, filed on any particular day till 3.00 p.m. shall be listed by filing branch on the next working day before the Ld. Judicial Officer on duty, who shall hear and dispose of the same, if he/she opines it to be an urgent matter.
2. The Ld. Judicial Officers on duty shall sign manually or digitally the final orders and / or proceeding sheets on the same day and shall ensure that the duly signed final orders and / or proceeding sheets get uploaded on the website.
3. It is clarified that matters of urgency in which pecuniary jurisdiction vests in the Courts of Civil Judges shall also be taken up by the above-named Additional District Judges.
4. It is further directed that on days when the above-named Judicial Officers are on duty, their Delhi resident staff shall report for duty in their respective Court. However, the Ld. Judicial Officers named above and their staff shall not be required to come to Court if no urgent matter is listed, though they shall remain available on call. Further all hearings be done preferably through Video Conferencing,

using Cisco Webex, to reduce congestion in Court building. And where the hearings are to be done inside the Court room, the Judicial Officer on duty shall ensure strict adherence to the norms of social distancing.

5. It is also clarified that the entire staff are directed not to leave station under any circumstances. They shall remain available on call and would be deemed to be on duty, as in case of any urgency, the undersigned and concerned Officer In charges may call upon them to report back on duty immediately.
6. All the Judicial Officers of West District are directed that the matters which are already fixed up to 02/05/2020 be adjourned en-bloc to subsequent dates as convenient or suited to the pendency of cases in their Courts and the information in this regard be uploaded on the website of the District and entered into CIS so that auto-generated messages are received by all concerned.
7. The Reader / Ahlmad / Asstt. Ahlmad instructed by the Ld. Reporting / Judicial Officer would ensure that the requisite details with respect to next date of hearing and its purpose is uploaded through CIS on the same day.
8. No Judicial Officer shall seek or remain on leave on the dates earmarked without permission of the undersigned.
9. The In charge, Computer Branch, Tis Hazari Courts, Delhi is directed to provide necessary assistance to the Ld. Judicial Officers for hearing the matters through Video Conferencing, as and when required.
