I am directed to convey that Hon'ble the Chief Justice has been pleased to approve the following recommendation of Hon'ble the State Court Management Systems Committee in respect of Digital NI Act courts:

"So far as recording of evidence is concerned, the Committee directed that feasibility of earmarking court room(s) in each District for recording of evidence on rotational basis, by the judicial officer dealing with these cases be explored. In the meantime, if the digital court records evidence through VC, one staff of the court may be treated as Remote Point coordinator and the witness may be asked to come to the seat of that designated staff for evidence."

I am therefore, directed to request you to bring the aforesaid to the notice of all the concerned for compliance. I am also directed to request you to share necessary information availability of the court room(s) for the aforesaid.
