## OFFICE OF THE CHIEF METROPOLITAN MAGISTRATE WEST DELHI Duty Roaster for the Month of August 2020

As verbally approved by the Ld. District and Sessions Judge, West Delhi, for the smooth functioning of the magisterial courts of west district Delhi, it is hereby ordered that the Ld. Metropolitan Magistrates of West District Delhi will work as Duty Magistrate-I and Duty Magistrate –II on the dates noted against their names for the month of August 2020. The regular duty MM of the day will be termed as Duty MM-01 and Additional Duty MM will be called as Duty MM-II. The Ld. Duty MMs are required to reach to court by 10:00 A.M. and remain there up to 05:00 P.M. or till the disposal of remand and other misc. work whichever is later. The work shall be divided as per the following schedule:-

Note:

- 1) In addition to aforesaid work, if any other matter of urgent nature is received after court hours and before 10 am of next day, the same shall be looked after by the Duty MM-I.
- 2) In pursuant to the office order of Ld. CMM Central THC Delhi, bearing No. 8952-9054/CMM/Central/SS/DM/2020 Dated 30-07-2020 it is order that the fresh arrestees shall not be produced in District complex but shall be produced in the Court Complex situated in tihar Jail and Mandoli Jail premises before 5 p.m. Fresh arrestees produced after 5 p.m. shall be dealt with the Ld. Duty Magistrate-I(after 5p.m.)
- 3) Ld. Duty MMs-I of the day shall extend remand of intimate through video conferencing pertaining to Tihar Jail No. 2 through V.C room of the court complex in Post Lunch session as per circular of Ld. C.M.M. Central THC Delhi bearing no.8952-9054/CMM/Central/SS/DM/2020 dated 30-7-2020.
- 4) Both the Ld. Duty MMs preferably hear bail, superdari and other urgent pplications / matters through VC/Webex as per rules of Hon'ble High court of Delhi in this regard.
- 5) All such applications in pending trial matters shall be heard by concerned court.
- 6) Bail applications or any other misc application in pending investigation matter shall be dealt by the concerned duty mm and any such applications in pending trial matter (where charge sheet had already been filed) shall be dealt by the concerned area mm. The application may be sent to the concerned area mm/duty mm at their email id of the said court.
- 7) Every fresh application should contain mobile number/email id of Ld. Counsels/litigants.
- 8) For recording of statement u/s 164 Cr.P.C., the concerned Ld. Duty MM may, instead of chamber, use the Court Room, Vulnerable Witness Deposition Room, Other appropriate room in the Court Complex or through Cisco Webex Platform to ensure norms of social distancing.
- 9) All the Ld. MM(s) shall comply the directions received from time to time regarding disposal of the work from Hon'ble High Court of Delhi and from Ld. District & Sessions Judge (West), Delhi.
- 10) The Ld. MMs deputed for duty and the staff of their courts who will work on Holidays will be entitled to avail Special Casual Leave (Compensatory Leave) in lieu of the duty performed on such day (s) as per rules. The special casual leave (compensatory) of the MMs shall be routed through and after verification by the undersigned. The MMs while forwarding the application of the staff for grant of such special casual leave (compensatory) shall verify that the official concerned had actually worked on a particular date.

- 11) All the MMs are directed to strictly comply with the directions passed by the Hon'ble High court of Delhi in W. P. (Crl.) 861/1997 titled U S.Pandey, President of W A S. Vs. U. O. I. & Ors while performing their duties as Duty M.M.
- 12) Staff of concerned Duty MMs shall fix VC/Webex meeting with all parties in advance and reader of 1st day Duty MM shall tell in advance to the staff of next day Duty MM to fix meeting through VC/Webex regarding pending applications.
- 13) All the link MMs of the Duty MMs of the day shall remain available to take over work in case duty MM is/are unable to perform duty on that day. In case Duty MM-1 has to leave court for inquest etc. then his link MM shall take over the duty on receiving such information, till 5 pm or disposal of work in court, whichever is later. It is also ordered that in such case if any Link MM joint the duties he/she shall hold the court from the court room of regular Duty MM-I/Duty MM-II and shall be assisted by the staff of Duty MMs on that day as the case may be. However the work after that will be taken up by regular Duty MM-1.
- 14) For hearing through VC/Webex meeting, rules of Hon'ble High court of Delhi shall be complied with.

Email id of the above said court is read as stated above. Rest of the condition shall remain unchanged as mentioned in the duty roasters which are issued earlier for the magisterial courts of West District Delhi.
