**Re-Advertisement for Engagement of Legal Aid Defense Counsel (LADC) under the J&K Legal Services Authority**

The Legal Aid Defense Counsel System (LADCS) has been implemented across all 20 districts of the UT of J&K to provide effective, professional, and accessible legal services to underprivileged and disadvantaged communities, in accordance with Section 12 of the Legal Services Authorities Act, 1987.

However, due to poor response and inadequate number of eligible candidates applying for the advertised positions, the J&K Legal Services Authority (J&K LSA) has decided to cancel the previous notification No. LSA/LS/96/2022/1435-39 dated 09.08.2024.


